#### **CHAIRMAN'S MESSAGE**

We celebrated our 4th Anniversary in 2023 as we resumed our physical engagements and activities leaving the shadow of the COVID-19 pandemic behind us.

We are pleased to highlight some of our major milestones:

- Siglap Community Club for the use of their facilities to run our 2nd Drop-in Centre.
- MacPherson Community Club, Youth Network for the partnership to provide outreach and opportunities for the youth to quit vaping. About 100 vapes were deposited during the 40 days Anti-Vaping Campaign. It was launched by Ms Ting Pei Ling, Advisor to MacPherson SMC.

#### **Review of Financial Results**

For the year ended 31 March 2024, Bilby had an income of \$356,449 as compared to \$154,754 in FY2022, including the matching grant of \$67,470. We managed to achieve a surplus of \$146,710 in this Financial Year.

#### **Future Outlook**

We will launch our flagship programme called "Bilby Odyssey" by the end of this year as part of our 5th Anniversary Celebrations. Look out for details coming your way soon.

#### **EXECUTIVE DIRECTOR'S MESSAGE**

The Code of Governance for Charities was revised in Apr 2023 to raise the standards of governance in the charities sector. As a responsible Board, a decision was made to employ a professional Executive Director who has knowledge and experience in leading governance practices in the sector.

So, here I am, starting October 2023. This will add a new dimension to Bilby's progress in its programmes and services.

As a first step in financial governance, we saw the need to automate our bookkeeping and accounting process. For this, we are grateful to Oracle who as part of the Oracle NetSuite Social Impact initiatives, provided us with their software donation and training. We went live with NetSuite Cloud in Feb 2024.

2024/2025 will see us forge new and stronger collaborations with government agencies, corporates, and freelance social/youth workers, to help us progress in three main areas, namely:

#### 1. Human Capital

We intend to adopt TAFEP best practices. We will tap on SGUnited Mid-Career Pathway to cater for matured personnel joining us. And for new entrants to our job offerings, we will introduce Career Trial. And as we deploy youth workers to the schools and our drop-incentres, our investment in training and development for all our youth workers is inevitable.

#### 2. Programmes and Services

With mounting competitiveness and market demands, we plan to introduce our own Bilby Odyssey programme that is value-based, shaped by characteristics of the Bilby animal.

#### 3. Technology

Technology and multi-media currently are and will continue to be a game changer. Thus our Bilby Odyssey programme will have to incorporate technology and gamification that resonates well with youths. We have garnered interest from IMDA and NCSS into supporting this initiative, and their funding will allow us to work with our corporate partner, Digital Dream, in providing immersive and experiential technology in our programmes.

To sustain all of these, we need to raise our donations and fundraising efforts, coupled with an application to be an Institution of Public Character (IPC).

Wrapping up our fourth year since establishment, Bilby Community Development Ltd. continued our efforts into supporting our youths' growth and development - through the implementation of new programmes and various outreach efforts to engage them.

In 2023, we continued our efforts with our partnering schools - providing meaningful activities to engage with the youths and supporting their development of social emotional competencies and life skills. Our good work showed - with the 9 schools we partnered with in 2023, 7 carried on the partnership with us into the year 2024.

Outside of our work based in schools, we also expanded our work into the community - setting up another Youth Drop-In Centre at Siglap Community Club, in partnership with Siglap Youth Network.











#### YOUTH ENGAGEMENT PROGRAMME: AFTER SCHOOL ENGAGEMENT / GEAR UP

Bilby's Youth Engagement Programmes in Secondary Schools support the schools' After School Engagement and GEAR UP Programme.

Through our programme, we connect youths with our Youth Workers in school-based Student Activity Centres. Through sports, games, music, and art, our Youth Workers support the youths' psychological and social well-being. We design workshops to enhance social and emotional skills (e.g., self-awareness, emotional regulation) and offer skill-based workshops (e.g., arts, music, cooking). The aim is to provide essential psychosocial and emotional support, creating a safe space for youths to open up about hidden worries. Youth Workers assist youths with urgent issues (e.g., self-harm, mental health challenges) by providing support and referring them to appropriate channels for further help.



# COMMUNITY-BASED YOUTH DROP IN CENTRES: Collaboration with Youth Networks

In 2022, Bilby partnered with MacPherson Youth Network to establish a Youth Drop-In Centre, providing a safe space for youths to spend their time outside of school hours. During the sessions, youths participate in various activities such as art, crafts, and sports with our Youth Workers, and have the opportunity to voice their concerns and worries. Those facing difficult transitions receive support and mentorship from our Youth Workers.

In the first quarter of 2024, Bilby launched our second Youth Drop-In Centre at Siglap Community Club in collaboration with Siglap Youth Network. Since its opening in February, the centre has attracted over 40 youths who have enjoyed activities such as Nintendo Switch, beading, board games, and table tennis.



#### **EXAM WELFARE PACK GIFTING 2023**

In September 2023, we conducted our second Exam Welfare Pack Gifting to motivate and encourage our youths for their upcoming Final Year Examinations! Raising about \$2,000, we managed to pack and gift out 200 Gift Packs to our clients!

# ANTI VAPING CAMPAIGN w/ MacPherson Youth Network

To tackle the rising trend of vaping among youths in Singapore, Bilby teamed up with MacPherson Youth Network to organize an Anti-Vaping Campaign in the heart of MacPherson. The campaign aimed to raise public awareness about the risks and harms of vaping, and to engage participants through mentoring. The campaign was graced by MP Tin Pei Ling, who graciously showed her support.

Over the course of about two months, we collected over 100 vape devices and reached 72 participants. Half of these participants engaged further with us, and 20% expressed willingness to receive support for a healthier lifestyle.



## ANTI VAPING EXHIBITION @ NTU HERE4U

After our campaign at MacPherson, we were invited by NTU's Well-being Office to set up a booth to showcase our efforts and raise awareness about vaping among their students.

At the exhibition, we conducted a mini quiz to educate participants on the dangers of vaping and to highlight our campaign findings. This exhibition attracted over 200 quiz participants, and we also engaged with students who visited our booth to share more about our work.

# YEAR END EVENT @ SENTOSA SILOSO BEACH

To celebrate the end of the year and keep our youths engaged, we organized a day out at Sentosa's Siloso Beach. This event provided an opportunity for the youths to gather with friends during the Year End School Holidays and allowed our Youth Workers to catch up with them and check on their well-being.

We enjoyed activities such as playing volleyball, swimming in the sea, and indulging in snacks and drinks. We concluded the day in the late evening with Ben & Jerry's Ice Cream!
